Call to Order: Chair Weidner called the meeting to order at 5:00 p.m.

**Approval of Agenda:** Mastalir moved and Pabich seconded seconded to approve the agenda. Motion carried.

**Approval of Minutes:** Mastalir moved and Pabich seconded seconded to approve the February 13 minutes. Motion carried.

**Tour of County Jail Facilities:** Various members toured the current jail facility. Van Erem guided the tour and provided information as to jail operations and challenges faced with the current jail facility.

**Discussion of Current Jail Facilities:** Members commented on the age of the facility and the how the staff must employ "work arounds" to ensure that the facility operates. Discussion surrounded lack of space, the age of the facility and the difficulty staff faces in conducting their responsibilities. There appeared to be consensus that the current facility is outdated and lacks sufficient space.

**Discussion of Study Group Mission Statement:** Feldt reviewed the draft of the mission statement. General discussion followed as to the purpose of the mission statement. Cornelius offered alternative language. The group agreed that the mission statement should be short and relate specifically to the facilities. The Committee directed Feldt and Cornelius to present a mission statement for approval at the next meeting.

**Discussion of Study Group Goals:** Feldt reviewed the goals put forth for the committee. General discussion followed regarding the goals and suggestions offered by Baker. Wagner moved and Benes seconded to incorporate the language offered by Baker into the committee goals. Motion carried.
