23.01 Authority. The Kewaunee County Board of Supervisors adopts the provisions of this ordinance pursuant to the authority granted in Sections 59.51, 59.52(6), and 59.56(9) of the Wisconsin Statutes.

23.02 Off-Road Motorcycle. An Off-Road Motorcycle is a lightweight motorcycle built for cross country, unpaved, rough or uneven ground. Off-Road Motorcycles are equipped with rugged tires and suspension to make travel across rough terrains possible. Off-Road Motorcycles are also known as “dirt bikes” or “trail bikes.”

23.03 Kewaunee County ATV Park. Off-Road Motorcycles may be operated on the Kewaunee County ATV Park provided the following conditions are met:

- (1) All Off-Road Motorcycles shall be registered as set forth in s. 23.04 below by Kewaunee County.
- (2) Each Off-Road Motorcycle shall visibly display the registration label on the Off-Road Motorcycle.
- (3) Each Off-Road Motorcycle shall follow all rules established pursuant to s. 23.05 for operating an Off-Road Motorcycle on Kewaunee County ATV Park.

23.04 Registration.

- (1) Each individual Off-Road Motorcycle shall be registered prior to being operated on the Kewaunee County ATV Park.

- (2) Registration shall include the Name, Address, and Telephone number of the Owner as well as the make, model, year and a brief description of the Off-Road Motorcycle.
 - (3) Kewaunee County shall collect a fee of \$25 per Off-Road Motorcycle registration. A minimum of \$15 of each registration fee collected shall be used for maintenance of the Kewaunee County ATV Park. The remaining proceeds of the registration fee shall be retained by Kewaunee County for general purpose revenue to offset administration costs.
 - (4) Kewaunee County shall provide a self-adhesive label or some other means for each registered Off-Road Motorcycle to visibly display registration on the Off-Road Motorcycle.
 - (5) Registration is non-transferable.
- 23.05 Rules. The Promotions and Recreation Committee shall develop specific rules regarding the use of Off-Road Motorcycles on the Kewaunee County ATV park. A copy of the rules shall be displayed at a prominent location at the ATV park and copies shall be made available by the Kewaunee County Promotion and Recreation Department.
- 23.06 Violations. Violations of this Ordinance, including any rules adopted by the Promotions and Recreation Committee, may be prosecuted by the use of a citation form which complies with the requirements of Section 66.0113 of the Wisconsin Statutes.
- 23.07 Penalties. Any violation of the terms of this Ordinance shall be punishable by forfeiture not to exceed \$250.00 plus the costs, fees and surcharges imposed by Chapter 814 or the Wisconsin Statutes.
- 23.08 Effective Date. This ordinance shall take effect upon the first day of the month immediately following its adoption.
